Extinguishing media	
Suitable extinguishing media	: Use an extinguishing agent suitable for the surrounding fire.

Specific hazards arising from the chemical	: Extremely flammable aerosol. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion.
